

 Statement of Judgment by the Court:

This action came before the Court for a trial by jury. The issues have been tried and a verdict rendered in favor of the Plaintiff DW Business Systems in the amount of One Hundred Thirty Thousand Dollars (\$130,000.00) Actual Damages and Two Hundred Dollars (\$200) Punitive Damages Judgment entered for the Plaintiff DW Business Systems in the amount of one hundred thirty thousand dollars (\$130,000.00) actual damages and two hundred dollars (\$200) punitive damages. For the counterclaim, the jury rendered a verdict in favor of the Defendant Amy Gerard in the amount of zero (\$0). The Court granted the Defendant's Motion for Additur in the amount of one thousand five hundred twenty-seven dollars and forty-six cents (\$1,527.46) which represents the only competent evidence of the value of the personal property at the time of its conversion.


